1.0 Neighborhood Council Elections

1.1 Final review and action regarding the Community Impact Statement related to recommendations from Department of Neighborhood Empowerment to the City Council regarding On-line voting and 2018 NC elections. This pertains to City Council File 15-1022-S2. The two main recommendations include limiting ballot styles to 3 and requiring 20% of NC budget to be spent on election outreach.
